# ACCEPTANCE OF THE AGENDA

Anderson moved and Thies seconded to accept the agenda with the removal of item 3 Carnegie Ellsworth Building.

Vote: Anderson, Thies, Hampe, Knudson and Messa voting aye.

## **APPROVAL OF MINUTES**

Messa moved and Knudson seconded to approve the minutes of the regular meeting of April 20, 2010.

Vote: Messa, Knudson, Thies, Hampe and Anderson voting aye.

## APPROVAL OF MONTHLY CLAIMS

Messa moved and Knudson seconded to approve the monthly claims. Roll Vote: Messa, Knudson, Thies, Hampe and Anderson voting aye.

Thies moved and Hampe seconded to approve the following items:

## 2. First Christian Church Block Party

## 4. Budget Amendment

a. Mayor Welden opened the public hearing on an amendment to the FY2009/2010 Budget. There were no oral or written comments. Mayor Welden closed the public hearing.

b. Messa moved and Anderson seconded to approve Resolution No. 2010-11 amending the current budget for the Fiscal Year ending June 30, 2010. Roll Vote: Messa, Anderson, Knudson, Thies and Hampe voting aye.

### 5. <u>Sale of City Owned Lots</u>

The Council reviewed the list of city owned properties that could be sold.

Messa moved and Anderson seconded to advertise the properties for sale, work with the City Attorney on the language in placing the ad and that 716 Washington Avenue be sold with a commercial development agreement, with bids being brought to the July City Council meeting for consideration. Roll Vote: Messa, Anderson, Knudson, Thies and Hampe voting aye.

### 6. **Police Station Garage Roof**

Knudson moved and Messa seconded to approve the quote from Iowa Falls Roofing in the amount of \$6,579 for additional insulation for the garage roof.

Roll Vote: Knudson, Messa, Anderson, Thies and Hampe voting aye.

Hampe moved and Anderson seconded to use funds from the building maintenance fund 78 to pay for the additional insulation.

Roll Vote: Hampe, Anderson, Messa, Knudson and Thies voting aye.

## 7. <u>Street Garage Roof</u>

Anderson moved and Thies seconded not to extend the warranty from 15 to 20 years. Vote: Anderson, Thies, Knudson, Hampe and Messa voting aye.

### 9. Electric Fence

Anderson moved and Thies seconded to approve the request from Mike Kappel to be allowed to have an electric fence in a residential district at 908 North 1st for a five year period. Vote: Anderson, Thies, Knudson, Hampe and Messa voting aye.

#### 10. **Preconstruction Agreement with the DOT**

Anderson moved and Knudson seconded to approve the Preconstruction Agreement with the Iowa Department of Transportation.

Vote: Anderson, Knudson, Thies, Hampe and Messa voting aye.

#### 11. **Elk Run Treatment Plant Improvements**

Messa moved and Knudson seconded to approve Change Order #3 in the amount of a \$1,751.08 for additional roofing plus \$0.80 per square foot for insulation up to \$900. Roll Vote: Messa, Knudson, Thies, Hampe and Anderson voting aye.

b. Anderson moved and Knudson seconded to approve the request from Henkel Construction for a 30 day extension to substantial completion of the project. Roll Vote: Anderson, Knudson, Thies, Hampe and Messa voting aye.

Messa moved and Anderson seconded to approve Pay Request No. 6 to Henkel c. Construction in the amount of \$203,465.44. Roll Vote: Messa, Anderson, Knudson, Thies and Hampe voting aye.

#### 12. Ordinances

Discussion was held in regard to an Ordinance amending the Code of Ordinances of the a. City of Iowa Falls, Iowa, by amending provisions pertaining to parking regulations. Revisions will be made and brought back to the next meeting.

Anderson moved and Messa seconded to approve on first reading an Ordinance amending b. the Code of Ordinances of the City of Iowa Falls, Iowa, by repealing Section 66 Commercial Vehicles and adding Section 66 Load and Weight Restrictions.

Roll Vote: Anderson, Messa, Hampe, Thies and Knudson.

### 13. **Street Patching**

Anderson moved and Hampe seconded to reallocate crack sealing funds to be used for patching pot holes.

Vote: Anderson, Hampe, Thies, Knudson and Messa voting aye.

### 14. Leaf and Brush Fee Ordinance

Messa moved and Hampe seconded to approve on first reading an Ordinance amending the Code of Ordinances of the City of Iowa Falls, Iowa, by adding a new subsection in regard to leaf and brush fee. Roll Vote: Messa, Hampe and Knudson voting aye, Thies and Anderson voting no.

### 15. **Employee Handbo**ok

Knudson moved and Anderson seconded to approve Resolution No. 2010-12 adopting the new Employee Handbook.

# 16. Bad Debt Resolution

b. Knudson moved and Anderson seconded to approve the appointment of Suzanne Campbell to the Historic Preservation Commission filling an unexpired term with that term ending January 2011. Vote: Knudson, Anderson, Messa, Hampe and Thies voting aye.

c. Messa moved and Thies seconded to approve the appointment of Dave Gritsch to the Planning & Zoning Commission filling an unexpired term with that term ending May 2011. Vote: Messa, Thies, Hampe, Knudson and Anderson voting aye.

d. Thies moved and Knudson seconded to approve the appointment of Micah Cutler, Randy Smith and Rob Wohlert to the Planning & Zoning Commission for terms expiring May 2015. Vote: Thies, Knudson, Hampe, Anderson and Messa voting aye.
